



## 2025-2026 TUITION AND FEE AGREEMENT

Please take a moment to read the fee agreement information and sign below indicating you understand and accept the terms of the Tuition and Fee Agreement with St. Michael's Episcopal Preschool for the 2025-2026 school year. Then select one of the payment options advising the financial administrator of your intent. If financing for the first time is the option you choose, please complete the parent name and address information.

1. A registration fee of \$250 for each student is due at the time of registration. Also, there is a \$250 supply fee/tech fee for each child for the school year, and a \$175 annual non-parishioner fee due for each family. A registration fee of \$25 for extended care is due at time of registration. Please see additional paperwork for registration of extended care. All fees are non-refundable.

2. The school administration may require a student to stay out of school if the tuition or fee payments are not made according to the terms listed herein and in the financing document.

3. There will be a \$25 annual loan origination fee for all loans by Gulf Coast Bank.

5. Tuition Financial Form and Statement will be mailed to parents in June of 2025.

Select one of the two payment options:

A. \_\_\_\_ I agree to make a lump sum payment to the financial administrator by the deadline of June 5, 2025, for the total amount of tuition as shown on the Tuition Financial Form and Statement.

B. Gulf Coast Bank is offering St. Michael's Episcopal Preschool families a Tuition Financing Program at the rate of 8.75% for those who wish to finance the tuition over 10 months (July 2025 through April 2026). The ten monthly payments are due on either the 1<sup>st</sup> or the 15<sup>th</sup> of each month. Payments made after the designated date each month will be assessed a late fee. Should a parent not be able to make a payment by the last day of the month, they must contact the Head of School to discuss the situation. The bank will cancel the loan of any individual who has not made a payment within a time specified by the bank. If the bank cancels the loan, the remainder of the current year's tuition **becomes due immediately and is payable directly to the school.** ([www.tuition.gulfbank.com](http://www.tuition.gulfbank.com))
